REQUIREMENTS:

All players must be active USTA members. Annual junior USTA membership is \$20 per year, visit www.usta.com. Team Captains will be responsible for ensuring player registration and score reporting in TennisLink. In an effort to ensure player safety and a positive experience, all team captains and co-captains will be required to go through the USTA Georgia Background Screening Process and Youth Protection Training online course to be completed before the start of season play.

Parent involvement is required for the 8u division. The focus of the division is to introduce match play in a non-competitive environment. Children ages 6-8 who have participated in a series of lessons with an emphasis on serving and are familiar with keeping score are best suited for this division.

REGISTRATION is a two-part process:

Step 1: Complete form and return to your pro/captain. Pros/captains will organize teams.
Step 2: Online registration. Your pro/captain will contact you and provide you with TennisLink registration instructions. Fees will be paid online via credit card. NO Refunds after TennisLink registration.
